

# Tennessee Credit Union Hall of Fame

In a joint meeting of the Tennessee Credit Union League (TCUL) and Volunteer Corporate Credit Union (VolCorp), a decision was made to recognize the valuable leadership and contributions of credit union people in the state of Tennessee. This decision led to creation of the Tennessee Credit Union Hall of Fame, awarded each year, to recognize the commitment, leadership and dedication that deserving individuals have made to the credit union movement. Sponsored jointly, representatives from the TCUL and VolCorp will appoint a panel of judges to select the award winner from nominations, and present the award at the Tennessee Credit Union League Annual Meeting and Convention.

## **Call for Nominations**

Nominations are now being accepted for the 2011 Hall of Fame Inductee.

Inductees are chosen by a panel of judges who consider the following criteria when making their selections:

- ❖ **Years of service to the credit union system;**
- ❖ **Positions of leadership on the state, local or national level;**
- ❖ **Demonstrated commitment to the credit union philosophy and services; and**
- ❖ **Credit union system educational accomplishments and support.**

“All credit union employees and volunteers are eligible for induction”. Nominations can also be made posthumously. Once a person is nominated, their nomination remains active and their form is resubmitted to the judges each year.

As mentioned above, the 2011 Hall of Fame Inductee will be honored during the Tennessee Credit Union League Annual Meeting and Convention. The TCUL Annual Meeting and Convention is scheduled for May 18-20, 2011, at the Gatlinburg Convention Center in Gatlinburg, TN.
